Official Contest Rules & Regulations – SPRING BLOG CONTEST

The contest starts at 12:01 AM ET on Wednesday, February 17th, 2010 and continues until Tuesday, May 18th, 2010 at 11:59 PM ET. There are no restrictions on the number of entries you may submit provided each entry corresponds with a different space. All entries must follow the process detailed under "How to Enter" below.

How to Enter:

1. To participate in the Battle for the Best Blunder Contest you should email your home decorating "blunder" (or problem / question). Entries must be under 200 words to qualify. You must also send at least two (2) corresponding photographs with your submission (.jpg format only). Entries will only be accepted by email:

This Contest is conducted by M.D.H. Interiors Inc. (the "Contest Holders") and is only open to residents within a 100 km radius from Kitchener-Waterloo. Entrants less than the age of eighteen (18 years) require the consent of a parent or legal guardian. All entrants must have the legal right to make any desired alterations to their space.

Conditions of Entry:

1. Entrants (i) acknowledge compliance with these Official Rules including all eligibility requirements and, (ii) agree to be bound by the decisions of Contest Holders, made at their sole discretion, which shall be final and binding in all matters relating to the Contest. Entrants who have not complied with these Official Rules are subject to disqualification.
2. Contest Holders are not responsible for: late, delayed, lost, stolen, damaged, misdirected, mutilated, garbled, illegible, destroyed or incomplete entries. All entries become the property of the Contest Holders, will not be acknowledged as received and in no case shall be returned to the entrant or sender.
3. By entering the Contest, all entrants, - (those under the age of majority, his/her parent or legal guardian), consent to the use of their name, submitted home pictures, address (city and province) and/or likeness, without further compensation, worldwide and in perpetuity, in any and all forms of media, now known or hereafter devised, including the Internet, in any publicity or advertising carried out by the Contest Holders.

How to Win:

1. The winner of The Battle for the Best Blunder will be chosen by a majority of votes received from the members of the "Contest Committee" (members chosen at the discretion of M.D.H. Interiors Inc.) subject to final approval by the Contest Holders.

otherwise disclose personal information of entrants with third parties. Contest Holders will not reveal the identity of any voters.
